**Description:** 14.5 linear ft.

**Scope and content:** Records chiefly consist of company archive files (1986-2002) pertaining to landscape architecture consultation and design projects and studies of Dargan Landscape Architects (formerly Hugh Dargan Associates) in and near Charleston (S.C.), and, to a lesser extent, in Camden, Columbia, Florence, and a few other South Carolina locations.

The Charleston archive files include textual descriptions, slides and photographs (some with negatives), teaching plans, and working drawings of residential gardens primarily located in the Charleston historic district, with related correspondence and clippings. There are also files for projects pertaining to hospital and apartment complex grounds in Charleston, grounds of the Unitarian Church (4 Archdale Street), Grace Episcopal Church (98 Wentworth St.), Washington Square Park, and The Blessing Plantation in Berkeley County (S.C.). Charleston archive files contain information on gardens and grounds of homes in Charleston (S.C.) on Anson, Archdale, Beaufain, Broughton, Chapel, Church, East Bay, Gibbes, Greenhill, Hasell, Hutton, King, Ladson, Lamboll, Laurens, Legare, Meeting, Murray, New, Orange, Portside, Rebellion, Rutledge, Savage, Short, Smith, Society, South Adger's Wharf, South Battery, State, Tradd, Warren, Weims, and Wentworth streets and on Bedon's Alley and Zig Zag Alley.

Included are oversized landscape design plans (drawings) for The Blessing Plantation and many Charleston properties, including addresses on the following streets: Anson, Bedon's Alley, Chapel, Church, Greenhill, Hasell, Laurens, Legare, Murray, Rutledge, Society, South Battery, Tradd, Warren, and Zig Zag Alley. Additional archive files, mostly photographs and plans, pertain to projects in Camden, Columbia, Florence, and several other cities and towns in South Carolina including Mount Pleasant, Beaufort, Sumter, and Georgetown.

Records also include a company history, biographical information about Hugh and Mary Palmer Dargan, and notes about the company archives.

Hugh Dargan, a landscape architect, is a native of Darlington County, S.C. His wife, Mary Palmer Dargan, a native of Nashville, Tenn., received her master's degree in Landscape Architecture from Louisiana State University in 1981. The Dargans practiced in Charleston, S.C. for 12

years and in 1993 moved to Atlanta, Ga., where the company is now headquartered. The Dargans taught a course on landscape design offered through the Dept. of Continuing Education at the University of South Carolina in Columbia, South Carolina for several years.
