Biographical/Historical Note: South Carolina family. George Paddon Bond Hasell (1781-1818) was born in South Carolina and attended the University of Edinburgh as a medical student. While in Scotland he married Penelope Bentley, and their children included Andrew Hasell (1803-1866) and Bentley Hasell (1807-1836). Bentley Hasell was the father of Lewis Cruger Hasell (1830-1889), a physician and plantation owner of Georgetown County, S.C. Andrew Hasell (1803-1866) was a physician, South Carolina legislator, and plantation owner. He owned Cedar Grove Plantation in All Saints Parish and practiced medicine on plantations along the Waccamaw River. He married his cousin Joanna Weston.

Scope and Content: Papers consist of medical accounts, a medical daybook, medical lecture notes, plantation papers, and other items. Included are the papers of Lewis Cruger Hasell (1830-1889), George P.B. Hasell (1781-1818), and Andrew Hasell (1803-1866).

Papers (1803-1816) of George P.B. Hasell consist of a medical account book (1812-1816) for patients, mostly Georgetown County plantation families and slaves; and five notebooks (1803-1804) containing lecture notes on subjects such as midwifery and the diseases of women and children, with notes on lectures by Dr. Alexander Monro of Edinburgh University. Family names mentioned in the account book include Harleston, Quash, Shubrick, and Ball. Also included is a copy of "Medico-Chirurgical Transactions" (London, 1812), with an annotated index.

Papers of Andrew Hasell (1803-1866) consist of two account books (1830-1856) recording Dr. Hasell's treatments, prescriptions, and charges for many Georgetown County plantation families and their slaves; and a medical daybook (1841-1850) noting patients' illnesses and charges. Families mentioned include Alston, Allston, Belin, Middleton, Carson, Ward, Weston, and others.

Families mentioned in account books include: Alston, Allston, Berlin, Carson, Frasier, Gadsden, King, LaBruce, Middleton, Tucker, Ward, Weston, Wrightman, Hemmingway, Pyatt and others.

Georgetown Co. planter. Plantation records (1871-1884) of L.C.Hasell. Included are tax returns (1871); notes on crops, accounts; agreement with Arthur B. Flagg regarding boundary of Woodland Seashore Plantation; list of workers sick and other accounts with laborers. Plantations mentioned include Sandy Island, The Oaks, Crowfield, Springfield, Cedar Grove, and Laurel Hill, Georgetown.
