



**St. Michael's Church Records, 1751-1989**  
**SCHS Call # 320.00**

**Description:** 17 linear feet

**Biographical/Historical note:** St. Michael's Parish was created in 1751 to accommodate the growing urban population of Charleston, S.C. Construction on the church began in late 1752 and it opened in February 1761.

**Scope and content:** Records are arranged according to the officer or administrative body by whom they were created: auxiliary organizations, clergymen, collectors, commissioners, historians, treasurers, and vestry and churchwardens.

Records of numerous auxiliary organizations, 1861-1950, include such bodies as the Altar Guild, Epiphany Guild, General Guild, Ladies' Aid Society, Men of St. Michael's, Women's Auxiliary, Young People's Service League and the Working Society.

Several small collections of papers represent some of the clergy that have served at St. Michael's, including Edward Jenkins, John Kershaw, Paul Trapier, and Thomas John Young.

The records of the church collector include accounts of pew and glebe rents collected and statements or returns of these funds delivered to the treasurer, 1778-1890. The financial accounts and statements contained among the treasurers' records are incomplete, but there is a substantial collection of individual vouchers or receipts spanning the years 1763-1961.

Records of the churchwardens and vestry include correspondence, 1762-1983, minutes, 1759-1949, and property records, ca. 1760-1989. Besides documenting the general activities of the church, these records, along with the collector's statements, contain a substantial amount of information about the use of St. Michael's glebe lots, which were bounded by Beaufain, Coming, Wentworth, and St. Philip's Streets in Charleston.

Extant records of baptisms, marriages, and burials are incomplete and scattered: one register of burials, 1817-1860, one register of baptisms, 1862-1879, a memorandum book of Edward Jenkins, 1780-82, a private register of Paul Trapier, 1830-1864, and several private registers of Thomas John Young, 1827-1852.

Also included in this collection is the 1809 manuscript "Choirmaster's Book" compiled by Jacob Eckhard, who served as organist of St. Michael's between 1809 and 1833. This book, which contains numerous hymn tunes and anthems used at the church, was published in facsimile in 1971.

A small but historically significant group of records in this collection relate to the body of commissioners appointed by the South Carolina provincial government to oversee the construction of St. Michael's in the 1750s. Their records, covering the years 1751 through 1763, include correspondence, financial records, pew applications, and a secretary's daybook. Of particular note among these records are several tally sheets that document the laborers (mostly

slaves) who erected the brickwork of St. Michael's, October 1752 through November 1754, including the names of slaves, their owners, and the number of days worked.

Mrs. Ward to surrender such part of lot [obscured letters—"lot"?] 28  $\frac{3}{4}$  as will extend lot 28  $\frac{4}{4}$  with its present width back 2<sup>nd</sup> lot on Wentworth Street also numbered 28 in consideration of \$96.52 of the arrears of rend being remitted. Mrs. Ward to surrender to remainder of the lot as forfeited and to receive from the [V]estry and Wardens a lease for her li[fe] on the same terms as she now has [and] all back rent except the aforesaid \$96.52 being also paid."

\*\*Slave Labor Tally Sheets, 1752-1754  
St. Michael's Episcopal Church, Charleston

These sheets document the names of the slaves who built the exterior walls of St. Michael's Episcopal Church, the number of days they worked, and the names of the slaves' owners. Also included are notations of significant events, such as the discharge of several overseers and the completion of the steeple brickwork (9 October 1754).

The steeple of St. Michael's was damaged by a tornado in the autumn of 1938. During subsequent repairs, these tally sheets were discovered among the steeple timbers. Rolled tightly and very brittle, the sheets were too fragile to be examined. They remained in this state until October 2003, when Nicholas Butler, archivist of the South Carolina Historical Society, conserved them using handmade Japanese paper and simple flour paste.
