VISUAL MATERIALS RESEARCH

1. Upon receiving your request, you will be advised of the availability of images requested, time frames, and any specific charges involved. SCHS staff will conduct about 30 minutes of research at no charge. After the initial 30 minutes, a research fee applies.

Please be aware that there is no guarantee that images will be located, and in some cases, the SCHS archives may not contain relevant images.

2. When finished researching, SCHS staff will either mail photocopies of the images or email low-resolution scans of the images to the patron. Please note the schedule of fees below.

3. To obtain permission to **publish** an SCHS image, please submit the accompanying “Visual Materials Publication Request” form located on the SCHS website. Separate publishing fees apply.

*To receive a price quote for irregular sized scans or prints, please contact SCHS archival staff.

**If a patron uses five or more images in a single project, a discount of 20 percent will apply to the use fees.

*** In some cases, it is necessary to burn the images to a CD and mail it out. The cost per CD is \$2 (as many images as possible will be placed on the CD). The patron pays for shipping of the disk or is free to pick up the item at our office.
