Creator: Aimar family.

Biographical /Historical Note: Family of Charleston, S.C. Charles Pons Aimar, Sr. (1826-1905), son of Sebastian Aimar and Adele Maynard (Mesnard), was an accountant and part owner with G.W. Aimar, his brother, of White House Plantation (originally located in Colleton County, S.C., in an area which is now part of Charleston County, S.C.). He married Octavie Picault and their children were Marie Devineau, Arthur Aimar, Charles Pons Aimar, Jr., and Lillie Aimar. C.P. Aimar, Jr. (1873-1927) was a surgeon and physician. He married Leonarda Jaques (1873-1953), daughter of Richard Eugene Jaques and Jenny Lind A. Gambatte, in 1898. They had one daughter, Agatha Aimar Simmons (1900-1982), who married Thomas Ritchie Simmons, a Charleston attorney, alderman, and hotel manager, in 1929. She was active in many organizations and was involved in genealogical and historical research. Agatha Aimar Simmons and Thomas Ritchie Simmons had two daughters, Mary Ritchie Simmons Tutterow and Charlotte Simmons McQueeney.

Scope and Content: Aimar family papers (1834-1980) consist of correspondence (1834-1980; n.d.), estate and financial records, property records, slave records, and miscellaneous items. Included are papers of Charles P. Aimar, Sr., C.P. Aimar, Jr., Agatha Aimar Simmons, T. Ritchie Simmons, Mary Ritchie Simmons Tutterow, the Shaffer family, and the Simmons family.

Papers (1841-1915) of Charles P. Aimar, Sr. consist of estate and financial records; military and wartime records (1864-1865), including documentation pertaining to Aimar's service as a volunteer fire fighter in Charleston (S.C.); and other items. Some of the financial records, which consist of receipts and account books and mostly date in the 1880s and 1890s, pertain to a plantation, probably the "Home Place" (or White House Plantation?). A merchant's ledger (1841-1843) includes accounts for shipping.

Papers (1900-1965) of Thomas Ritchie Simmons consist of business records, mostly relating to the Timrod Corporation (operating the Timrod Hotel in Charleston, S.C.); legal documents pertaining to the case of A.J. Kealey v. estate of Patrick Broderick (1900-1908); the will (1954) of Daisy D. Van Ness; school and employment records; clippings; memorabilia; financial records; political papers, mostly pertaining to Simmons' candidacy for magistrate in 1938 and city alderman in 1948; and other items.

Papers (1941-1979) of Mary Ritchie Simmons Tutterow include genealogical information, her will, and diaries.

Simmons family papers (1878-1982) include financial and property records, as well as genealogical data on the related Tutterow family of North Carolina. Property records (1878-1915) chiefly pertain to tracts of land in Colleton County (S.C.), and land in Transylvania County (N.C.).
