Biographical/Historical Note: Charleston, S.C. naval officer, forester, and writer. John Henry Bennett (1907-1969) was born in Charleston to the writer John Bennett (1865-1956) and Susan Smythe Bennett (1878-1965). He attended Exeter Academy (N.H.) and Yale University, and then worked for the U.S. Forest Service. During World War II he served in the U.S. Navy and afterwards worked at the Charleston Naval Base. He published one novel, "So Shall They Reap," in 1944.

General Note: Photographs have been removed to the SCHS photograph collection.

Scope and content: Papers consist chiefly of correspondence, the bulk of which (1922-1945) are letters from John Bennett (1865-1956) containing detailed descriptions of events in the Bennett household and in Charleston. Topics include family matters, social events, the arts, politics, and the elder Bennett's literary works and his relationship with the Poetry Society of South Carolina and other Charleston organizations. Forestry-related papers (1934-1940) illustrate John Henry Bennett's work in the U.S. Forest Service in Berkeley and McCormick counties in South Carolina. Other materials include artwork, clippings, ephemera, literary notes and drafts, photographs, and personal reminiscences.

Other members of the Bennett family represented in this collection include John Henry Bennett's mother, Susan Smythe Bennett, his sisters Susan Adger Bennett and Jane McClintock Bennett Wells, and his son, John H. Bennett, Jr. (1945-2000). Also included are reminiscences (ca. 1900) of Dr. William Harleston Huger (1826-1909) as told to Susan Smythe Bennett. Bennett family papers include transcriptions of song lyrics and music collected or composed by John Bennett, Sr. or other Bennett family members, including 19th century songs from Virginia and folk music.
