## **Christian Family Y Records, 1908-2003** **SCHS #0593.00**

**Creator:** Christian Family Y of Charleston, South Carolina

**Description:** 15 linear ft. (25 boxes + 29 scrapbooks)

**Biographical/Historical Note:** The Young Women's Christian Association (YWCA) of Charleston, S.C. was formed in 1903, and chartered in 1906 when the YWCA of America was officially formed. In 1967, after several years of discussion, the board of the YWCA voted to disaffiliate itself from the national organization. In 1971, the national YWCA sued the Charleston YWCA over the use of the name "YWCA" and in 1972 the Charleston YWCA changed its name to the Christian Family Y of Charleston." In 2003 the CFY changed its name to Charleston Family and Youth, and the following year, it closed due to financial problems.

**Scope and Content Note:** Collection consists of minutes, scrapbooks, financial records, property records, records reflecting various events and programs such as the annual Tea Room and Festival of Tables, records (1990s) relating to the construction and maintenance of a swimming pool, and miscellaneous items. Minutes include records of the meetings of the YWCA and CFY Board of Directors and the Auxiliary Council. The minutes of the meetings from the late 1960s focus on the Charleston YWCA's concern over the movement of the national YWCA from its Christian roots and efforts to secularize activities. Miscellaneous papers include an essay about the history of the Charleston Y.W.C.A. written for its 50<sup>th</sup> anniversary, a chronological history (1962-1966) mainly pertaining to the building program and pool, correspondence, constitutions and by-laws, a cookbook, a report (1913) of a subsidiary organization or committee, Travelers Aid, at Union Station, and a "Transcript of Trial, The National Board of the Young Women's Christian Association of the U.S.A., Plaintiff, vs. Young Women's Christian Association of Charleston, South Carolina, Defendant," 1971. A series of alphabetically arranged administrative files also contains records of events and programs, pool records, financial records, and Auxiliary Council records, as well as newsletters and membership records. Other than a state registration form (2003), there are no records in this collection pertaining to the organization's operations under its last official name.
