Historical Note: The original typewritten Finding Aid has been converted into a word-searchable digital document.

Scope and Content: The papers of Arthur Middleton of South Carolina, a member of the Continental Congress, chiefly consist of correspondence and memoranda concerning both public and military affairs in Charleston (S.C.) and Philadelphia (Pa.), and such issues as the currency, the national debt, motions made in Congress, and naval and army defenses. There are also notes in code about deliberations in the Continental Congress, including notes on the Articles of Confederation. Correspondents include Aedanus Burke, John Mathewes, Charles C. Pinckney, and Edward Rutledge.

PREFACE

This collection is arranged in three major divisions:

Correspondence- letters to and from Arthur Middleton concerning occurrences during the last years of the Revolutionary War in South Carolina, as well as family matters. At the time of this correspondence he was in Philadelphia as a member of the Continental Congress. Some of the letters in this section are by others. (see list of correspondents in the Table of Contents).

Memoranda and notes- largely concerning resolutions, motions, and committee reports during Arthur Middleton's years in Congress. Also miscellaneous lists, accounts, and bills are included in this section.

Letters and notes in cypher-of these items in cypher,or Arthur Middleton's shorthand, 38 have been decoded by the Department of the Navy. Their translation of this code is included in 38-54 of this inventory. (see pages 18-22 for individual items).

- 38-32-1 W. Shirley, Governor, Bahama Islands, to Edward North. License to the Master of the sloop Betsey.
 9 Sept., 1767.
 W. Savage to Colo. Laurens. Letter about Captains Stirrup and Tucker. 13 Oct., 1767.
- 38-32-2 Henry Middleton, Goose Creek, to Arthur Middleton. Family letter concerning plantations, news, etc. Some mention of the Regulators. 22 Sept., 1768. Published <u>SCHM</u>. XXVII, 108.

The King's government naked and exposed. Third addressed to "Sir", possibly Graves. Five large boats from South Carolina armed with 100 men have been in harbor ten days awaiting arrival of vessels from London with gunpowder which report says will try to take and it is not in the power of the writer to prevent. 27 June, 1775. - 38-34-1 P[ierce] Butler, Coosaw River, to [Arthur Middleton]. Letter. Need of a standing army in North Carolina, South Carolina, and Georgia. Militia in settlements unsatisfactory for "war has become a science." So many overseers in militia near seacoast that planting is neglected. - 38-37-3 Aedanus Burke, Petersburg, to Arthur Middleton, Philadelphia. Letter. Expresses surprise that the British made so poor a showing at York. Finds some South Carolina negroes with the British troops. 18 Nov., 1781. Published: <u>SCHM</u> XXVI, 188.
- 38-37-4 Edward Rutledge, Petersburg, to Arthur Middleton, Philadelphia. Letter. Heard report that the enemy has evacuated Wilmington. - 38-40-5 Charles Cotesworth Pinckney, Camp near Bacon's Bridge, to Arthur [Middleton, Philadelphia]. Personal letter. Reports on condition of Middleton's family; news of Rutledges and Pinckneys. Calvary has used so much forage that there is not enough left to supply the country. Georgia distressed for provisions. Gov. Mathews has already sent them 500 barrels of rice. Urges that report on provisions not prevent the sending of more men. Gen. Barnwell has been made Brigadier of Militia and his brigade refuses to serve under him. 24 Apr., 1782. - 38-41-6 Jno. Mathews, Cane Acre, to Arthur Middleton, in Congress, Philadelphia. Letter. Concerning evacuation of Charlestown and occupation of Ashley River plantation by the British. They are now at Wragg's and expected at his (Middleton's) in a day or two. Will protect Mrs. Middleton. The army is wanting almost everything hence the laxness of discipline. 26 June, 1782. - 38-42-2 Charles Cotesworth Pinckney, Ashley River, to Arthur Middleton, Philadelphia. Letter. The Army nearer to Middleton's place; not so easy to prevent the soldiers from marauding when they are so poorly paid. 10 July, 1782. Published: <u>SCHM</u> XXVII, 66.
- 38-42-3 Edw[ard] Rutledge, Ashley River, to [Arthur Middleton]. Letter. Family news. Account of the condition of the Army, no clothes, little fuel, no pay, and no rum. 11 July, 1782. Published: SCHM XXVII, 18.
- 38-43-1 Charles Cotesworth Pinckney, Ashley River, to Arthur Middleton, Philadelphia. Letter. Families of Edward Rutledge and the writer have removed from Pon pon and are under his (Middleton's) roof; evacuation of Charlestown about to take place. Refugees who wish to quit the town to be transported to East Florida. Leslie has sent out flags to propose exchange of prisoners. Merchants sent out a deputation to get permission to remain. 13 Aug., 1782. Published: SCHM XXVII, 64.

- 38-43-2 Francis Skelly, A.D.C. to General Leslie, to Capt. Ker. Letter. General Leslie will not allow any liquors to be carried out of town. Endorsement signed G.K. says interest not adequate. 25 Aug., 1782.
- 38-43-3 John Sanford Dart, Headquarters, Ashley Hill, So. Carolina, to Arthur Middleton, Philadelphia. Letter. Joseph Caly, deputy pay master general to the Southern Army has resigned. Writer has been nominated by Gen. Greene and would like Middleton to use his interest to get the nomination confirmed by Congress. 25 Aug., 1782. Published: <u>SCHM</u> XXVII, 73.
- 38-43-4 Jno. Mathews, Uxbridge, Ashley River, South Carolina, to Arthur Middleton, Philadelphia. Letter. Judge Burke's horses taken by South Carolina troops and returned. Rice stolen by the British. Col. Laurens, imprudently attempting to maintain his ground, fell. The enemy preparing to evacuate Charlestown and delayed by lack of transports. Comment on behavior of the enemy and asks that this be brought to the attention of Carlton by Washington. Encloses letter from Francis Marion. Letter concluded on Sept. 1. 25 Aug., 1782. Published: <u>SCHM</u> XXVII, 69.
- 38-43-5 Ra[lph] Izard, to [Arthur Middleton]. Letter. Genl. Washington has sent Lippencott's trial to Congress which is reading it now. Thinks it likely the affair will be committed and if he is not well enough to come to Congress this day he may still be present for the decision of the question. 26 Aug., 1782. Published: <u>SCHM</u> XXVII, 74.
- 38-43-6 Francis Marion, Wadboo, St. John's, to Gov. J. Mathews. Letter. Gives account of battle near Biggin Bridge, Major Frazier with 100 horses and some coloured dragoons attacked. Capt. Robert Gillis of the enemy killed. 30 Aug., 1782. (Probably the copy mentioned in letter of Gov. Mathews to Arthur Middleton, 25 Aug- 1 Sept., 1782) Published: <u>SCHM</u> XVII, 176.

- 38-44-1 [South Carolina Delegation in Congress], Philadelphia, to [Gov. Jno. Mathews]. Letter. Have received letter sent by Mr. Sansum. Pleased to learn of impending evacuation by British. Enclose resolution of Congress respecting Gen. Greene's continuing in the South. Congress will ask 1,200,000 be raised from the states by taxation or other means for public debts and obligations. Congress will offer the <u>America</u> to France to replace the <u>Magnifique</u>, lost in Boston harbor. Cartel, trial of Lippencott. Enclose copies of Gen. Washington's letters. 10 Sept., 1782. Published: <u>SCHM</u> XXVII, 77.
- 38-44-2 J[ohn] Middleton, Annapolis, to Arthur Middleton, Philadelphia. Letter. Has delivered letter entrusted to him. Sends news of a change in British ministry, derived from a British paper received from St. Thomas's. Would like to know if Charlestown has been evacuated. He intends to leave shortly with his horses to return to Carolina. 13 Sept., 1782. Published: <u>SCHM</u> XXVII, 72.
- 38-44-3 [Arthur Middleton], Philadelphia, to [Edward] Rutledge. Letter. Acknowledges letter sent by Mr. Sansum. Says all news has been included in letter to Gov. Congratulations on the "Belgic Declaration." Alterations in the British cabinet may retard pacification; if they do not soon "pocket their losses," and end the war the writer predicts the separation of Ireland and perhaps of Scotland and national bankruptcy. 17 Sept., 1782. Published: <u>SCHM</u> XXVII, 23.
- 38-44-4 [S.C. Delegation in Congress, Philadelphia, to Gov. Mathews]. Letter. Are sending duplicate of previous letter by Mr. Heyward. A ship from Amsterdam brings word that official independence has been acknowledged by the States General of the United Provinces on 19 April and Mr. Adams recognized as minister of the U.S. No authentic account of the Negotations for peace. Mentions British change of Ministry. Hear reports of intended evacuation of N.Y., hope to hear of Charleston. 17 Sept., 1782. Published: <u>SCHM</u> XXVII, 25.
- 38-44-5 George Washington, Headquarters, to President of Congress. Letter. Sends intelligence recently received from Canada that reinforcements are being sent to the British and the Indians have been dismissed. 26 Sept., 1782.

- 38-45-1 Ralph Izard, Philadelphia, to Arthur Middleton. Letter. Concerning Izard's property in S.C. Negroes carried off by the British, conduct of the states respecting revenue has totally annihilated all Continental strength and credit. 30 May, 1783. Published:SCHM XXVII, 78.
- 38-45-2 Arthur Middleton, Cedar Grove, to W.Z. Letter. Is too unwell to venture from home; asks that he be waited on by Mr. Glaze and addresses to make his returns of his taxables; he will give an order upon Mr. Smith, payable on sight. 3 June, 1783.
- 38-45-3 Arthur Middleton, Cedar Grove, to P. Smith. Letter. Sends list of medicines to be sent by Cesar to Butler, his manager. Orders salt and three grindstones. 16 June, 1783. With letter of June 18 to Mr. Butler.

A[rthur] M[iddleton], Cedar Grove, to "Mr. Butler." Letter. Is sending supplies requested by Pompey. Other plantation matters. 18 June, 1783.

- 38-45-4 Arthur Middleton, Ashley River, to P. Smith. Letter. About business; Mr. Harrison's account with regard to Mrs. Izard's affairs; share of the crop. Sends copy of Mr. Butler's account of work done at plantation; asks that Mr. Harrison return Mrs. M's copy of Buchan's Fam. Med. which Mr. Harrison took from Hobonny. 17 Aug., 1783.
