

# Harry L. Mills Papers, 1980-2001 SCHS# 0633.00

**Description:** 6 linear ft. (10 boxes + flat files + two boxes of visual materials)

Biographical/Historical Note: Harry L. Mills, a graduate of the Citadel, is a civil engineer. After serving in the Army Corps of Engineers for twenty years, he went to work for Figg and Muller Engineers as Resident Engineer for the Florida Department of Transportation on the Long Key Segmental Concrete Bridge. He later worked for Misener Marine Construction Company in Tampa, Florida, as Manager of Engineering, supervising the Harbor Island Development in downtown Tampa. After moving back home to Charleston, he worked for the South Carolina Department of Transportation managing the hired consultants overseeing inspections of several notable public works including the I-526 Wando River Bridge, the I-526 Cooper River Bridge, the I-526 Bridge, an urban section composed of concrete and steel girders connecting East Cooper and North Charleston, the Isle of Palms Connector, the James Island Expressway, and the SC 61 Connector. After the completion of these projects, Mr. Mills became the District 6 Bridge Engineer responsible for maintenance of bridges in the district, including the Grace and Pearman Cooper River Bridges and was subsequently promoted to District 6 Administrator.

**Scope and content:** Collection consists of correspondence, diaries, printed material, drawings, photographs, and other records relating to numerous bridge design and construction projects, mostly in South Carolina, including the Long Key Bridge (Florida), the John F. Limehouse Memorial Bridge, the I-526 Wando River Bridge (aka John B. Edwards Bridge), I-526 Cooper River Bridge (aka Don Holt Bridge), urban section of the I-526 bridge (North Charleston), the Isle of Palms Connector, the James Island Expressway, repairs to the Grace and Pearman bridges over the Cooper River, the Cross Island Connector (Hilton Head), and the Cooper River Bridge (aka Arthur Ravenel, Jr. Bridge).

The following is Mr. Mills' summary description of his papers:

The collection consists of documents spanning the professional career of civil engineer Harry L. Mills from about 1978 to retirement. (The documents do not include, though they mention, any details of work completed as a member of the Army Eng. Corps.)

The early documents relate primarily to work for the Figg and Muller Engineering Company as their resident engineer on the Long Key bridge project in Florida. Related documents include

construction reports, drawings, correspondence to/from contractors and agencies, clippings from print media, budget reports, etc. Also included are journal articles on the technology, "segmental bridge construction." Some of the items give a snapshot of the contemporary state of the civil engineering art, e.g., early computer aided design technology.

Later documents (from mid-1980s) cover other Figg & Muller projects nationwide briefly; Glenwood Canyon Bridge, Colorado; Escambia Bay Florida rail bridge; Linn Cove Viaduct on the Blue Ridge Parkway, N.C.; and I-526 Wando River bridge in spring 1984; Marta elevated rail, Atlanta. This section ends in 1987.

The South Carolina section covers bridge projects in South Carolina from about 1993 and later. These include Broad Creek bridge, Limehouse Bridge, Grace & Pearman bridges, Isle of Palms connector, Wando Bridge, James Island Expressway, etc. Details are provided for several of these projects by project coordinator's daily diaries. Diaries discuss events related to construction work including Hurricane Hugo.

Many items are included in the collection that provide general background including training handbooks, inspection manuals, drawings and elevations, bridge studies, conference reports, journal and news articles, legal depositions, photos, booklets, financial & feasibility studies, and others. A how-to is included that shows the steps to be taken for a bridge dedication ceremony.

Photographs and other visual materials have been removed to the Visual Material Collection. See itemized description at the end of the finding aid.
