

Ethel Trenholm Seabrook Nepveux papers, 1933-2008 (bulk 1974-2000) SCHS# 0638.00

Biographical/Historical Note: Ethel Trenholm Seabrook Nepveux was born in Georgetown, S.C., in 1912. She was the daughter of Alfred Glover Trenholm and Ethel Moore Lofton Trenholm, and the great-granddaughter of George Alfred Trenholm (1807-1876). After her mother's death in 1922, Ethel was raised by her aunt and uncle Gertrude and Julius Seabrook and took their name. She attended Winthrop and graduated from the College of Charleston, where she met her future husband Felix J. Nepveux. She was a teacher, writer, and historian, and her writings included two books about her ancestor George Alfred Trenholm and a book about Sarah Henry Bryce (Mrs. Campbell Bryce). Mrs. Nepveux passed away in 2017.

Scope and content: This collection chiefly consists of research and correspondence relating to Ethel Trenholm Seabrook Nepveux's books about George Alfred Trenholm and his companies John Fraser and Company of Charleston, S.C., and Fraser, Trenholm of Liverpool, Nassau and Bermuda. Correspondents include Thomas M. Boaz, John Howells, and Bob Thorp. Specific areas of research include various blockade runners and their captains, as well the Fraser, Trenholm and Company Business Archive at the Merseyside Maritime Museum, including copies of the correspondence of Charles K. Prioleau. These papers also reflect Mrs. Nepveux's interest in the submarine *H.L. Hunley* and Charleston's wartime history of the 1860s. Related items include some of her articles and lectures and related illustrations on transparencies. Other papers consist of genealogical research on the families of Bryce, Holmes, Lofton, Nepveux, Rhame, Seabrook and Trenholm, including memoirs of Josephine Trenholm Lyman and Eliza Florence Trenholm Macbeth. Personal and family papers include letters of Felix J. Nepveux written during his Korean War service, family photographs, and correspondence and records relating to Nepveux property on Goat Island and the Goat Island Corporation.

Photographs have been removed to the Visual Material Collection.
