Description: 75 linear ft. (71 boxes + 16 drawers)

Scope and content: Collection consists of records pertaining to numerous landscaping projects designed and implemented by landscape architect Sheila Wertimer, ASLA, and later, Wertimer and Associates, Landscape Architects, mostly in Charleston and environs, but also other locations in South Carolina and elsewhere. Records include correspondence, notes, drawings, plans, invoices, and photographs, mostly relating to residential landscaping. Projects include the Calhoun Mansion (16 Meeting Street), the Charleston Riverdogs stadium (Joseph P. Riley Jr. Park), the Gibbes Museum (and Gibbes Art Gallery), the cemetery and social hall of Kadal Kadosh Beth Elohim (KKBE), Marion Square, Millford Plantation (Sumter County), Mulberry Plantation (Berkeley County), Poco Sabo Plantation, Roper Hospital, St. Michael's Episcopal Church churchyard, Yeamans Hall, White House Plantation (Colleton County), Cypress Gardens, and the Arthur Ravenel Jr. Bridge.
