



**John E. Huguley Papers, 1956-1996**

**Description:** 12 linear feet (26 boxes + 14 scrapbooks)

**Biog./Historical Note:** John Earl Huguley (1927-2010) was a prominent businessman and civic leader of Charleston, S.C. He was a native of Jefferson County, Alabama, and after having served two years in the U.S. Navy during World War II, he graduated from the Citadel in 1951 with a degree in business administration. He went to work for Legerton & Company in Charleston in 1951, became president of the company in 1959, and purchased it in 1969, renaming it the John Huguley Company. His stores, generally called Huguley's, sold office supplies, books and other products. John E. Huguley was active in many professional and civic organizations, serving as president of the Exchange Club of Charleston (1959), the United Way (1970), Trident Chamber of Commerce (1971), and the South Carolina Historical Society (1973-1974). He was also chairman of the Bethel United Methodist Church board of trustees.

**Scope and content:** Collection consists of business records of Legerton & Company and the John Huguley Company, and personal papers of John E. Huguley mainly reflecting his activities in local and state politics and commerce, as well as various civic, professional and non-profit organizations. Records of the John Huguley Company include advertising materials, store catalogs, inventory data, scrapbooks, and records relating to branch stores in the Charleston area.

Organizations represented in John E. Huguley's personal papers include the Berkeley-Charleston-Dorchester Council of Governments, the Business-Education Partnership, Citizens for Good Government (an organization promoting the consolidation of city and county government), the Downtown Council, Downtown Retail Merchants Association, Charleston-Trident Chamber of Commerce, Charleston Merchants Housing Association, South Carolina Merchants Association, the South Carolina Chamber of Commerce, Historic Charleston Foundation, the South Carolina Historical Society, United Way, the Exchange Club, Patriots Point Naval Museum, and Bethel United Methodist Church. Also represented are committees and councils on which he served including the Charleston Area Transportation Study (C.H.A.T.S.), the Charleston Police Study Committee, Building Economic Solutions Together (B.E.S.T.), the Fort Sumter Delegation, the Headquarters Committee, and the Charleston County Transportation Advisory Council.
