

# James Barnwell Heyward genealogical papers, 1901-1929 SCHS 268.00

Creator: Heyward, James Barnwell, 1848-1931.

**Description:** 1.25 linear ft.

**Biographical/Historical note:** A native of South Carolina, James Barnwell Heyward was the son of William Henry Heyward (1817-1889) and Esther Barnwell Heyward (1819-1904). As a teenager he served in the last years of the Civil War (1864-1865) and spent the latter part of his life in Georgia.

**Scope and content:** Papers consist of correspondence (1921-1929), research, family charts (oversize), and drafts of a family history pertaining to the genealogy and family history of the Heyward family of South Carolina and related families including Barnwell, Bellinger, Bryan, Bull, Calhoun, Elliott, Gibbes, Gignilliat, Huger, Izard, Jones, Middleton, Perry, Screven, Simons, and Smith.

These materials served as the research notes for a comprehensive history of the Heyward family, for which James B. Heyward prepared three typewritten drafts. Each draft includes copious annotations and corrections in pencil by the author, and the third, bound draft contains a few 19th century documents (letters and receipts). After James B. Heyward's death in 1931, this Heyward family history was edited and published by Halcott Green Heyward and Mary Law Heyward.

Heyward's Confederate service, 1864-1865. A series of letters, 1923-1929, between various Heywards and the College of Heraldry, concerns discrepancies in the record of the Heyward coat-of-arms.
