

Clelia Peronneau Mathewes McGowan Family Papers, 1835-2003 (bulk 1884-ca. 1950) 0368.00

Biographical/Historical note: Clelia Peronneau Mathewes McGowan was a South Carolina politician, social activist, and writer who spent most of her life in Abbeville and Charleston. She was born in Columbia in 1865 to William Raven Mathewes and Eliza Peronneau Mathewes. In 1883 she sailed to Sweden to live for a year with the family of her mother's former governess, Mrs. Rosalie Roos Olivecrona, who was formerly a teacher at Limestone College (Gaffney, S.C.). This experience fortified a relationship with the Olivecrona family that would last into the 1960s. Clelia married William Campbell McGowan, a successful Abbeville lawyer, in 1885 and the couple had four children: Samuel, William Campbell, Jr., Rosalie Olivecrona, and Mary Miles. After her husband's death Clelia returned to Charleston where she became a distinguished civic leader. She served on the South Carolina Board of Education for seven years, and, after a successful bid for city council in 1923, she became the first woman elected to public office in Charleston. She spent the rest of her days in Charleston writing poetry and serving on various organizational boards, such as the Committee on Better Race Relations, the Charleston Free Library, the Garden Club, and the Poetry Society.

Scope and Content: Clelia P.M. McGowan's papers consist of autobiographical writings, clippings, family correspondence, ephemera, genealogical notes, photographs, poetry, and information regarding her civic and political activities. Materials relating to the connection between Eliza Peronneau Mathewes and her daughter Clelia, and the Swedish family of Rosalie Roos Olivecrona comprise a separate section of the collection. These materials include clippings, correspondence, genealogical notes and photographs of the Olivecrona family, and Clelia's journals kept during her trip to Sweden in 1883-1884. Autobiographical writings include information on antebellum times, plantation life of the Peronneau family at Dungannon, and the burning of Columbia (S.C.) by Gen. Sherman.

Several other members of Clelia's family are represented in this collection, including poetry by her mother, Eliza Peronneau Mathewes, and juvenile writings by her daughters, Mary Miles McGowan and Rosalie Olivecrona McGowan Matthew. A small amount of materials representing the McGowan family, such as obituaries of her husband, William Campbell McGowan, Sr., and correspondence of Confederate general and South Carolina Supreme Court Justice Samual McGowan are also included. In addition, the allied families of Mathewes, Matthew, Peronneau, and Wardlaw are briefly represented through correspondence, financial records, and photographs.
