## **L. Mendel Rivers papers, ca. 1925-1995** **SCHS# 0141.00**

**Description:** 21 Linear Feet (54 Boxes)

**Biog./Historical Note:** L. Mendel Rivers was a United States Representative from South Carolina. Best known for his support of a strong military, Rivers spent nearly thirty years in Congress. He was a member of the Armed Services Committee of the House of Representatives and served as its chairman from 1965 to 1970. A Democrat, he represented the Charleston-based 1<sup>st</sup> Congressional District. He was born in Gumville, Berkeley County, S.C., on September 28, 1905, and was the son of Lucius Hampton Rivers and Henrietta Marion McCay Shepard. He married Margaret Middleton in 1938, and their children were Peggy, Marion and Mendel, Jr. He died on December 28, 1970, and is buried at the St. Stephen Episcopal Church cemetery in Berkeley County.

**Scope and content:** Papers include personal, family, and official correspondence; speeches; mementos of special occasions and trips; clippings; invitations; and files on various projects on state and federal projects within Rivers' congressional district. Included are extensive files compiled by Marion Rivers Cato as research for a book about her father L. Mendel Rivers. Correspondents include Frank Boykin (1940s-1960s), James Lamb (1940-1942), J.C. Long (1958; 1970), Chlotilde Martin (1955), John Wilson Patrick (1941-1942), J.R. Paul (1941-1943), Gus Pearlman (1941-1942), Joseph P. Riley (1967-1971), Roland Wooten (1950s-1960s), E.B. Rodgers (1941-1944), President Harry Truman (1951), O.T. Wallace, George Warren (1941-1943), and Strom Thurmond.
