

New England Society records, 1819-1995 SCHS 209.00

Creator: New England Society of Charleston, S.C.

Description: 8.75 linear ft.

Biographical/historical note: Founded in January, 1819, this organization was formed by "a number of gentlemen, natives of New England, for the purpose of keeping alive in their minds the memory of the land of their birth, and the institutions handed down from their fathers. Another, higher object with them, was to organize an efficient system of relief for such of the sons of New England as might be arrested by the hand of disease or chill penury in this city."

Scope and content: Records consist of correspondence, financial records, minutes, pamphlets and other printed material, speeches, and other items. Included are papers (1915-1952) of Rev. William Way.

Early correspondence (1819-1890s) includes letters of application for membership in the New England Society; letters of resignation; letters declining an invitation to dine with the Society; letters concerning charity cases, mostly native New Englanders who were in need of passage money home or other assistance; and miscellaneous correspondence. Later correspondence (bulk 1960s-1990s) chiefly consists of letters concerning membership matters.

Early financial records (1819-1893) include vouchers and orders to pay pertaining to charity efforts and other expenditures; and treasurers' accounts. Additional financial records consist of accounts, investment records, invoices, and checking records.

Miscellaneous items include eulogies, resolutions, Committee on Charity reports (1858-1893), lists of members, papers pertaining to various New England Society dinners and meetings (1967-1995), clippings, and membership certificates. Printed material includes editions (1830-1885) of the Rule Book of the New England Society; constitutions and by-laws in bound and pamphlet form (1876-1939); editions (1967-1991) of a pamphlet entitled New England Society of Charleston, S.C.; mortuaries (1874-1875); and pamphlets and a book (1859-1894) pertaining to New England Congregational churches. Speeches include manuscripts of addresses (1832-1850s) by Samuel Gilman.

Papers (1915-1952) of William Way consist of clippings, including reviews of his History of the New England Society; correspondence, including letters of appreciation concerning his book; and papers pertaining to the New England Society.
