

Tompkins and Reid families papers, 1930-2022 (Bulk 1940-2015) SCHS# 0690.00

Biographical/Historical Note: Wyatt Edward "Ed" Tompkins (1928—2018) was born in Taylors S.C., he was son of Wyatt James Tompkins (1906–1934) and Mary Jones Tompkins (1906—1975). He attended Greenville High School and was drafted into the Army before finishing his degree. He worked for time at infirmary ward in Japan before leaving Army, and he finished his high school education at Blue Ridge Prep School in Hendersonville, N.C., before attending Furman University on a football scholarship for one year. He married Mille Florence Center (1931—2022), the daughter of Robert "RC" Center (1910—1984) and Freddie Banks Center (1911—1964). Born in Neeses, S.C., she graduated from Parker High School in Greenville, S.C. and later worked for Furman University and Joyce Food Equipment. Wyatt Edward "Ed" and Millie Center Tompkins had three daughters, Cynthia Ann Tompkins Kinghorn (1952—), Edna Lynn Tompkins Whittle (1956—), and Susan Elizabeth Tompkins Reid (1960—).

Charles Hazel "Pete" Reid (1924—1981) was born in Greenville, S.C. the son of James Knox Reid (1896—1928) and Vinnie James Reid Gosnell (1902—1980). Charles "Pete" Reid left school at a young age to work in a textile mill to help support his family, which struggled after his father's death when Charles was four years old. Charles worked in the textile industry including at Monaghan Mill until his retirement. He became a member of the Shriner's, which he remained active in until his death in 1981. Charles "Pete" Reid married Constance Ivonell "Ike" Galloway (1932—) in 1950. Constance Ivonell "Ike" Galloway (1932—) was born in Greenville, S.C. the daughter of Charles Benson Galloway Sr. (1896—1973) and Ella Davis Galloway (1896—1989). She attended school in Charleston, S.C. for a few years, and graduated from Parker High School in Greenville, S.C. She worked in the textile industry and retired from McDonalds. Charles "Pete" and Constance Ivonell "Ike" had four children, Linda Reid Williams (1951—), Robert Steven Reid (1953—), Larry Dean Reid (1957—2020), and Gary Thomas Reid (1959—). The youngest daughter of Wyatt Edward and Millie Center Tompkins, Susan Elizabeth Tompkins married the youngest son of Charles "Pete" and Constance Ivonell "Ike" Reid, Gary Thomas Reid in 1981 connecting the Tompkins and Reid families.

Scope and content: Collection consists chiefly of correspondences, journals, diaries, newspaper clippings, genealogical information and images of the Tompkins, Reid and related families. The items related to the Tompkins family were compiled largely by Millie Center Tompkins (1931—2022) while the items related to the Reid family were compiled largely by Constance Ivonell "Ike" Galloway Reid (1932—). The collection includes personal papers related to Wyatt Edward "Ed" Tompkins, Millie Center Tompkins, Charles Hazel Reid, and Constance Ivonell "Ike" Galloway Reid. The papers of Millie Center Tompkins consist of newspaper clipping related to Greenville, S.C. and South Carolina, research that was conducted on the history of Duncan Chapel Elementary School in Greenville, S.C. Several personal diaries, journals, and

payer journals in which Millie writes about her life, experiences, family, world events, including the COVID-19 pandemic, and her personal thoughts and prayers for her family and friends. The collection contains a journal that was written by both Millie Center Tompkins and Wyatt Edward Tompkins in which they each write about the parents, early childhood memories in Greenville and Neeses, S.C, schooling, military service, meeting each other, marrying, and having children.
