

# Visual Materials from the Edward R. Ball Family Papers, 1800-1995 SCHS# 0631.00 VM

**Description:** 1.25 linear ft. (4 boxes)

**Biographical/Historical Note:** Edward Robbins Ball (1928-2019) was a Charleston realtor. Born in Summerville, S.C., he was the son of John Coming Ball (1885-1973), also a realtor, and Annie Arden Jervey Ball (1887-1975), who was the daughter of Francis Johnstone Jervey (1857-1895) and Ida Morris Jervey (1861-1938). Edward R. Ball's twin brother, Thomas Moultrie Ball, died in an accident in 1946. In 1952, Edward R. Ball married Joan Alward (1931-2014), the daughter of Ernest E. Alward (1899-1987) and Phoebe Chapman Alward (1899-1974).

Scope and content: Collection contains images of many Ball family members, principally the families of John C. Ball and his son Edward R. Ball and their forebears. There are also photographs relating to the related families of Alward and Moultrie. A significant portion of the collection consists of photographs of houses and other properties which were taken by John C. Ball or Edward R. Ball in their capacity as real estate agents. These include houses in Charleston and vicinity, Summerville, Sullivan's Island, Edisto Island, Georgetown County, and Berkeley County. Other photographs depict Ball family properties. Of note are images of the Sandy Bee House on James Island (1935), a cottage at Rice Hope Plantation, New Cut Plantation on Wadmalaw Island, Peter's Point on Edisto Island, Lowndes Grove, the Thomas & Howard Company store in Charleston, the Ball real estate offices in Charleston, the site of a Boy Scout camp on the Wando River, Brooklands Plantation on Edisto Island, and Dixie Plantation. Also of note are postcard scenes of the aftermath of a tornado in Charleston (1938?); and artwork, including a color lithograph of an engraving, 1857, of a Charleston harbor scene showing the waterfront, ships at wharves, sailboats, and Castle Pinckney.

<u>Note</u>: There are four cased photographs in the SCHS Cased Photograph Collection, located in Box 2, tray 6.
