

# Broughton family papers, 1713-1863 SCHS Call # 1011.00 Container 11/93

**Scope and content:** Papers consist of estate records, wills, property records, receipts, legal documents, slave records, and other items chiefly pertaining to the Broughton and Sanders families.

Estate records, including inventories, appraisements, accounts, receipts, wills, and other items, are for Joseph Sanders, a St. Bartholomew Parish planter (1764-1773); William Sanders (1775-1784); Ann Sanders (1786); Lawrence Sanders, a St. Paul's Parish planter (1789-1807); and Ann Broughton (1833-1836). Included are copies of the wills of Ann Broughton (1788); Peter Broughton of St. John's Berkeley Parish (1768); Andrew Broughton of St. George Dorchester Parish (1779); Nathaniel Broughton (1794); Elizabeth Damaris Broughton of St. John's Berkeley Parish (1835); Philip Porcher Broughton of St. John's Berkeley Parish (1835); Philip Porcher Broughton of St. John's Berkeley Parish (1808); Elizabeth Jane Ravenel (1802); and Daniel Ravenel (1774). Numerous slaves and plantations are named as bequests in wills.

Property records include a conveyance (1713) of land in old Berkeley County sold by Isaac Porcher to William Steed; a release (1734) of land in "St. George's Parish" from William Sanders to John Stevens; a lease (1760, oversized) of a plantation in "St. George's Parish", William Sanders to Charles Strother; release (1768) of 1500 acres in old Berkeley County, Elizabeth Woolford to William Sanders; conveyance (1818) from Dempsey Collins to James Daingerfield of a plantation on Blacktom Bay at Goose Creek; conveyance (1824) of a plantation in St. John's Berkeley Parish, sold by Ann Crandal to Anne Frances, a freewoman; a conveyance (1835) of Fairfield Plantation in St. John's Berkeley Parish, sold by William H. McCall to Zechariah Norwood; and survey plats (1717-1837, mostly copies) of land in Berkeley County.

Receipts include two receipts (1772) for quit-rent due on Berkeley County land; receipt books of Ann Sanders (1776-1786), Lawrence Sanders (1760-1775, 1781-1789), and Ann Broughton (1789-1810); and receipts (1827-1830) of Daniel and Alexander Broughton. Slave records include several slave bills of sale (1784-1836). Other items include a marriage settlement (1760) of William Sanders and Ann Broughton (d. 1786); correspondence (1782-1794) of Lawrence Sanders and [Ann] Broughton mainly regarding legal and financial matters; and notes (ca. 1835?) on the Broughton family and Mulberry Plantation.

### **11/93/1-13** Sanders Family, 1717-1801 Family Papers, 1717-1801. Approx. 50 items

St. George, Dorchester Co. planting family. Estate and other papers of various members of the Sanders family. Estate papers (1763-1773), wills, plat, queries regarding the estate and inventory of goods of Joseph Sanders. Papers (1777-1775) of William Sanders include a plat of land in Berkeley Co. (1717); leases for property on St. George, Berkeley Co. (1734, 1760), marriage settlements between WS & Ann Broughton (1760), a bond, the wills and estate accounts of WS. Bill of sale for slaves (1784), and estate papers (1786) of Ann Sanders. Laurence Sanders papers include will, list of slaves, and their prices (1801), lists of lands, deed of partition, estate account book (1789-1801) and letters (1782-1789) regarding business and financial matters of LS. Receipt and account books of LS and Ann Sanders (1760-1791) with estate account receipts of LS handled by Ann Broughton. Includes debt case (1789) of William Doughty and John Webb vs. Ann Broughton, executrix of Lawrence Sanders.

Mulberry plantation planters. Papers (1703-1863) of Broughton and related families. Includes grant of land in Berkeley Co. (1703) to Isaac Porcher; will of (1788) Ann Broughton; letters to "Miss Broughton" from Jacob Drayton regarding due notes for bonds (1793-1794); accounts and bill of sale of slaves for estate (1834-1836) of Ann Broughton. Also, receipts of Alexander and Daniel Broughton regarding family estate (1824-1835); wills (1768-1825) of Peter Broughton, Andrew Broughton, Nathaniel Broughton, Elizabeth D. Broughton, Philip P. Broughton, Thomas Broughton, Daniel Ravenel, and Elizabeth J. Ravenel; Broughton family history notes, including history of ownership of Mulberry Plantation, Berkeley Co.; Misc. plats and papers (1818-1863); and fragments of damaged letters.
