

## A.T.S. Stoney Map and Plat Collection, 1901-1932 SCHS #558.00

## Description: 16 items (oversized)

**Biog./Historical Note:** A. T. S. Stoney was a Charleston, S.C. illustrator, cartographer, and U.S. Army officer. Stoney served in U.S Army field artillery units in France and Germany during World War I. He worked as a draughtsman, surveyor, topographer, and civil engineer for the Nevada Northern Railway, the Port Utilities Commission of Charleston (S.C.), and the T.V.A. before returning to military service in 1942 in the U.S. Army air arm in North Africa. He was the son of Samuel Gaillard Stoney (1853-1926) and Louisa Cheves Smythe (1868-1939). His wife was Eliza Louisa Jenkins, daughter of Edward Jenkins.

**Scope and content:** Collection consists of sixteen maps and plats chiefly depicting properties in South Carolina including 21 and 23 Tradd Street (Charleston, S.C.), Medway Plantation, Parnassus Plantation, Middleton Place, Fenwick Island, Back River Plantation and Hitchcock Woods (Aiken, S.C.). One undated map shows a route from Savannah (Ga.) to Wormsloe Plantation. Many of these documents were created by A.T.S. Stoney, and a few pertain to phosphate mining. A map dated 1930 depicts various properties in Georgetown County including Estherville and Belle Isle Gardens.
