Biographical/Historical Note: Corresponding secretary of the Georgia Historical Society.

Scope and Content: This group of letters and documents, much of which pertains to Georgia history and prominent South Carolinians, was chiefly collected by I.K. Tefft of Savannah (Ga.). Most items are originals; some are photocopies. Several letters are addressed to Tefft and concern his inquiries about historic figures, autographs, and other matters.

Collection consists of letters of and documents signed by, among others, Isaac Mazyck, Arthur Middleton, John Neufville, Henry Laurens, Henry Middleton, Francis Kinloch, Henry Kollock, John Izard Middleton, Alexander S. MacKenzie, W.B. Calhoun, C.G. Memminger, Bishop England, William Gray, James DeVeaux, J.E. Holmes, and Robert W. Gibbes. Included is correspondence between George F. Holmes and William G. Simms as well as correspondence between John C. Calhoun and D.B. Mitchell. Also included is a photocopy of a speech (1844) by Rev. Stephen Elliott concerning the influence of the church in Georgia history.

Correspondence includes a fragment of a letter (n.d.) of Nathanael Greene concerning legal and political matters; a photocopy of a letter (1779) from Archibald Campbell, commander of British troops in Georgia, regarding prisoners of war and depredations by runaway slaves in Savannah; a letter (early 1830s?) to Col. Wade Hampton, Jr. from artist James DeVeaux which includes a ink sketch of a man fishing; and a letter (ca. 1850s) of Charles Mackay, a British traveler and author, commenting on his stay at the Mills House (hotel) in Charleston (S.C.). Other items include a document (1736) signed by S.C. Lt. Governor Thomas Broughton pertaining to the admininstration of the estate of Thomas Batchelor.

Deed of sale, 1697. 1 item

South Carolina planter. Deed of sale (1697) which transfers 75 acres of land in Berkeley Co from IM to Daniel Garrison.

Certificate of Agreement, 1721. 1 item

South Carolinian. Certificate of Agreement (4/28/1721) between AM, Benjamin Schenckings, and James Moore.

South Carolina official. Official paper (2/8/1736) regarding estate of Thomas Batchelar. Also receipts.

Indian Agent. Photocopy of letter (2/2/1818) from CK at Fort Hawkins to Gen. David B. Mitchell. Agent for Indian affairs regarding chiefs of Cuseetau request for funds owed them from proceeds of ferry, over Ockmulgee River with mention of chiefs' plans to join the Creek Indians.

Traveling performer. Letter from CM to B. Fuller humorously commenting on the Mills House Hotel, Charleston, and apparently quoting from current songs, with mention of debarking for Savannah, GA.
