Biographical/Historical Note: Charleston, S.C. engineering and contracting firm. W.R. Mayrant was general manager and S. Lewis Simons was secretary and treasurer of the company.

The Gadsden Manor Inn, located on Old Postern Road in Summerville, S.C., was built in 1906 by Robert W. Parsons.

Scope and Content: Records consist of invoices, receipts, freight bills, accounts, and a few business letters pertaining to the construction of a "lodge," residence, and outbuildings (kennel, tool house, and water tower) for R.W. Parsons of Summerville (S.C.). Invoices are for brick, nails, lumber, paint, roofing, and other building supplies.

Firms from which supplies and services were purchased include Charleston Iron Works, Carolina Portland Cement Co., Cameron & Barkley Co., M.H. Lazarus Co., Shepherd Supply Co., Geer Drug Co., William M. Bird & Co., Andrew J.Riley (plumber), Hughes Specialty Well Drilling Co., Halsey Lumber Co., Valk & Murdoch Iron Works, Leland Moore Paint and Oil Co., Bailey-Lebby Co., and Hazlehurst Electric Co. of Charleston (S.C); T.B. Miles, O.C. Sires & Bro., Lockwood's Sale and Feed Stables, A.C. Weston (blacksmith), Arnold W. Kornahrens, and The Summerville Brick Co. of Summerville (S.C.); Weddington Hardware (Charlotte, N.C.); Ludowici-Celadon Co. (Savannah, Ga.); G.A. Guignard (brick manufacturer), Carolina Lumber & Manufacturing Co., and The Columbia Stone Co. of Columbia (S.C.); Leaphart Lumber Co. (Leaphart, S.C.); Van Dorn Iron Works Co. (Cleveland, Ohio); and the McClamroch Mantel Co. of Greensboro (N.C.).
