## **Lockwood Family Papers, 1919-2010 (bulk 1940-1960)** **SCHS # 709.00**

**Description:** 0.6 linear ft. (2 boxes) + artifacts

**Biographical/Historical Note:** James Jervey Lockwood (1894-1961), a harbor master of Charleston, S.C., was the son of Captain Robert Henry Lockwood (1861-1925) and Ella Ann Whilden Lockwood (1863-1932). He was also a partner in the White Stack Towing Company and later operated a charter fishing company in his boat *Tiki*. His first wife, Lucy Rabb Lockwood, with whom he had four children, died in 1937. James Jervey Lockwood and his second wife, Rebecca Allston Duncan Lockwood (1907-1987), were the parents of Robert (“Rabbit”) Henry Lockwood, who was born in 1940. Robert H. Lockwood, a graduate of the Citadel, became a harbor pilot in Charleston. In 1970 he married Jean Louise Schill, and he later married Charleston news anchor and journalist Debi Chard.

**Scope and content:** Collection principally consists of papers of Rebecca (“Becky”) Allston Duncan Lockwood and her son Robert H. Lockwood, including correspondence, clippings, memorabilia, writings, and miscellaneous items. Artifacts of Robert H. Lockwood removed to the artifact collection include his St. Andrews High School ring; a “Dick Tracy Detective Club” badge; “Counter-Spy Junior Agents Club” badge and certificate; a Grace Episcopal Church Sunday School medal; a 1954 Boy Scouts Circus patch; Charleston High School pendant; a U.S. Coast Guard ring; Citadel medals, pins, cufflinks, and buttons; and various patches and badges. Oversized material consists of a photostat copy of the medical degree, 1850, of Henry Davis Green (1829-1902); State High School diploma of Rebecca Allston Duncan (Lockwood), 1925; and blueprint plats of Longwood Plantation in Berkeley County (n.d.). Two boxes of photographs have been removed to the Visual Materials Collection (0709.00 VM).
