Grimball family papers, 1756-1918 SCHS 1220.00 Containers 24/247-249

Description: 1.25 linear ft.

Biographical/Historical note: South Carolina family. Isaac Grimball (d. 1752), who owned lands in Charleston, Edisto Island, and elsewhere, married as his second wife Rebekah Sealy. Their son John Grimball (d. 1804) was a plantation owner of St. Bartholomew Parish (and later St. Luke Parish). His widow Elizabeth B. Grimball married Rev. Andrew Flinn of Charleston. John Grimball's son John Berkley Grimball, a St. Paul Parish plantation owner and state senator, married Margaret Ann Morris. One of their ten children was John Grimball (1840-1922), a naval officer and attorney.

Scope and Content: Papers consist of financial and legal records, correspondence, and other items. Included are the family papers (1790-1843) of Elizabeth Berkley Grimball Flinn; papers (1868) of Caroline S. Geddes; and papers and correspondence (1853-1918) of John Grimball (1840-1922).

Papers of John Grimball (ca. 1750-1804) consist of financial records including cotton sales accounts (1802-1803) with Waring & Smith, accounts (1789) for purchases of general store goods from Bunker & Co. (Coosawhatchie, S.C.), receipts, bonds, and accounts (1795) of John Grimball with the Georgia Treasury for treasury certificates and interest payments; an agreement (1792) to buy John Smith's plantation near Coosawhatchie Bridge; a bill of sale (1800) for slaves of John Everingham of Charleston (S.C.); a plat (n.d.) of a lot on South Bay Street (Charleston, S.C.); estimate and specifications for a double piazza (n.d.); a few letters; and estate accounts (1814).

Papers of John Berkley Grimball include receipts and invoices; a letter (1823) from Charles Besselleu at Spring Hill [Plantation] regarding plantation affairs; a list of slaves given cloth at Rock Spring [Plantation] in 1840, along with notes (1843) on Rock Spring crops and poultry; and a letter (1847) from Grimball to his sister Mrs. Wilkins concerning the division of their mother's estate.

Other items include bonds, receipts, a promissory note, and accounts (1756-1768) of Rebekah Grimball, including general store accounts with John Edwards & Co. and estate accounts; copies of testimonials for Prof. C.J. Hadermann (1832-1842); trust estate receipts (1892) for Berkley Grimball and others; a bond (1764) of John Davant, Jr. of St. Helena Parish to merchants Middleton, Liston & Hope; treasury certificates (1777) of Mrs. Ann Davant (d. 1786), who deposited 507 pounds in the Georgia Treasury "in order to receive the like sum again in Continental Dollar Bills"; and recommendations (1798) by a Georgia legislative committee

regarding treasury certificates issued in 1778 to Joseph [Atkinson] by O'Bryan and Wade.
