Christ Church Parish Records, 1694-2016 SCHS Call # 325.00

Description: 7 linear feet

Biographical/Historical note: One of the ten ecclesiastical subdivisions created in 1706 by the Church Act of the General Assembly. Christ Church Parish, Charleston District, South Carolina laid the foundation for Christ Church in Mt. Pleasant, South Carolina in 1707.

Scope and content: Collection contains records and documents from Christ Church Parish in Mount Pleasant (S.C.), dating from 1694 to 2016. Materials include vestry correspondence, financial records, insurance records, legal records, property records, vestry minutes, and registers. Correspondence (1765-1957) include letters from Rev. Albert A. Muller, William Hort, James Gregorie, Thomas Barksdale, Arnold Bonneau, James Hibben, and others. Financial records (1763-1963) include account books, poor tax records, subscription lists, receipts, and invoices. Legal records (1811-1856) concern equity suits between the vestry and other parties. Property records consist of a lease agreement from 1885 and items pertaining to repair work done on the church between 1810 and 1834. The vestry minutes (1711-2011) consist of manuscript volumes, 20th century transcriptions, and later 20th and 21st century volumes. Registers (1694-2016) contain records of baptisms, marriages, and burials performed at the church. There are also registers of services (1974-2016). The earlier vestry minutes and registers were transcribed in the early 20th century by Anne King Gregorie in preparation for her published history of Christ Church Parish.

Other items in the collection include secretary books (1928-1950) and minutes (1919-1928) from the Women's Auxiliary of Christ Church and annual lists (1826-1842) of the members of the Parish Society Auxiliary, which was affiliated with the Protestant Episcopal Society for the Advancement of Christianity in South Carolina. Also included are some records and correspondence from St. Andrews Chapel, which functioned informally as a chapel of ease for Christ Church until it separated from Christ Church in 1954.
